West Donegal Township Past to Present

(An ongoing saga of West Donegal Township by Mary Conrad)

During 2013, West Donegal Township celebrated its 175th year anniversary. A small group of Township residents created a history line of our notable events. We hope you came into the Township building and saw "Our Story". For anyone who may have missed it, future newsletters will create the steps it took to become who we are today. We hope you enjoy this fascinating journey as much as we enjoyed creating it for us.

William Penn was born in 1644 in London. His father, Sir William Penn, was an English Admiral and his mother was the daughter of a wealthy merchant. At a young age William caught smallpox so the Penn family moved to the country. Here he developed a love for horticulture and a love for running. He was educated in a private school affiliated with the Anglican Church. (There were no public schools.)

At age 15, William met Thomas Loe, a Quaker missionary. A year later he entered Oxford to continue his education. In two more years his parents sent him to Paris to expose him to another culture. Here he adopted a belief in free will and tolerance. In 1665, after he returned home, London was in the grip of the plague. William observed Quakers on errands of mercy but since they were not part of the state supported Anglican Church, they were arrested. *continued on page 5*

SPRING CLEAN UP DAY • Saturday, May 17, 2014

The West Donegal Township Spring Clean Up will take place on Saturday, May 17 between the hours of 7:00 am through 12 Noon. Unwanted items may be brought to the Township Garage Building, 7 West Ridge Road, Elizabethtown. Proof of residency in the Township will be required. No builders, contractors or commercial establishments will be permitted to discard unwanted items. The first standard pick-up size loads (or the equivalent) will be free. No larger sized trucks will be accepted. Due to continued increases in dumping fees and clean-up costs, additional pick up truckloads will be charged a fee of \$30.00. Donations, however, are appreciated to ensure the continuation of this event. Fees will also be charged for the following items:

Passenger car tires w/o rims	\$ 3
Passenger car tires w/ rims	\$5
Light truck tires w/o rims	\$10
Light truck tires w/ rims	\$13
Tractor/Tractor Trailer Tires	\$20

The following items will NOT be accepted:

- **Covered Devices** This includes TV's, computers, laptops, keyboards, monitors, printers, cell phones, etc.
- Hazardous Waste This includes auto fluids, cleaners, paint, pesticides, kerosene, etc.
- Building Materials This includes dry wall, concrete, shingles, siding, etc.
- Oversized Items- This includes boats, canoes, campers, etc.
- Yard Waste This includes wood, stumps, leaves, branches, etc.

This year's shredding event is scheduled for Saturday, September 13 from 8 a.m. to 12 p.m. at the Township building located at One Municipal Drive. As in previous years, services and equipment will be provided by Nexcut, a bonded and certified company who focuses on security, customer services and green business. You can watch while your paper is shredded into 3/8" confetti by bonded personnel and equipment.

As always, this event is free of charge to all residents/businesses that live or are located in West Donegal Township. Again this year, as it our wish to help others within our community, we are asking those participating in this event for donations of canned goods and boxed items. Please be generous as these donations will be given to the Elizabethtown Food Bank. Last year we donated more than 18 boxes of donated food. Their greatest needs include: canned meats, juice, canned/boxed pasta, jams/jellies and pancake mixes and syrup. Baby food and formula will also be accepted. Please no perishable items. Donations should be non-expired, nonbreakable, and all items should be in unopened containers. Glass, frozen food, fresh produce/meats or home-made food will not be accepted. It was a wonderful feeling to see the joy on the faces of the volunteers who accepted the donations as they realize your help is truly appreciated by those in need in our community!

2nd Annual Covered Device Recycling Event

Our 2nd annual covered device recycling event will be held Saturday, September 13 from 8 a.m. through 12 noon. This year Egreen from Ephrata will be the company providing the services to the Township. The drop off event will be held here at the Township building similar to last year. It is open to residents and businesses within the Township.

Egreen offers a free, safe, reliable and hassle-free way to dispose of your e-waste. Their specialty is properly recycling your unnecessary and unhealthy electronic waste.

These are the types of devices that we will be accepting at the event:

There is no charge for the residents/ businesses to dispose of these items at the event with the exception of televisions (both flat screen and others) and computer monitors for which there will be a \$10.00 charge per item (cash only). This is because it costs Egreen to dispose of these items safely due to the lead and CRT's in them. As with the shredding portion of this event, we will be asking for donations for our local food bank.

Egreen understands that keeping your confidential information thoroughly protected is of utmost importance. Because of this, Egreen crushes all hard drives and complies with GLB act and HIPAA mandates for hard drive disposal and also gives a document of destruction upon request. White Goods & Tire Curbside Pick Up

Saturday, April 26

All white goods and tires must be tagged and placed curbside the night before collection. Tags cost \$12.00 per white good and \$3.00 per passenger car or motorcycle tire and must be purchased at the Township office. If you have tires larger than a passenger car or motorcycle tire contact the Lancaster County Solid Waste Management Authority at 397.9968 for disposal of these items. There will also be a White Goods & Tire pick up on October 18.

Spring Cleanup

Saturday, May 17 from 7:00 a.m. to 12 Noon. There are associated fees for this year's pick up for more than one truckload of items. See the enclosed newsletter article for details.

Woody Waste and Yard Waste Collection

Woody Waste and Yard Waste will be collected every other Tuesday from April 8 through October 7. Yard Waste needs to be placed in Kraft bags. Again, this season no tags are required and there will be **no** cost to you! You will be required to come to the Township office to sign out the number of bags that you will need with a maximum of 20 bags at a time. Any yard waste placed in plastic bags during this time will not be collected. Woody Waste should be bundled with biodegradable twine, not longer than 4' in length and not more than 6" in diameter. These items should be placed curbside the night before collection with your regular trash but will be collected by a separate recycling truck.

Yard waste after October 7 should be placed in with the regular trash. There is a 3-bag limit on the trash that you may place curbside each week. Extra trash tags (yellow) may be purchased for \$5.00 per strip containing four tags. Refer to the section below relating to **LEAVES** only.

Leaf Pick Up (after October 7)

The Township will be offering 4 leaf collections in the fall:October 21November 18November 4December 2

Leaves must be in brown biodegradable Kraft bags and placed curbside the night before collection. Kraft bags are available at the Township office free of charge.

Holiday Trash Schedule

Memorial Day – Trash and recycling collection will be delayed by one day and collection will occur on **Wednesday**, **May 28**. **4th of July** – Trash and recycling will be on **Tuesday**, **July 1**st, on its regular schedule.

Labor Day- Trash and recycling pick up will be Wednesday, September 3.

Reminder:

Trash must be in 32-gallon trash bags or cans and weigh less than 30 lbs. All recyclables should be #1 or #2 plastics (**with a neck only**). Other plastic items such as margarine tubs, take-out containers even if they have #1 or #2 on them are not recyclable and should be placed in the trash. Also recycle all glass containers, aluminum cans, newspapers, all small cardboard boxes such as cereal, shoes, etc., paper towel rolls (anything similar made out of cardboard), magazines, and junk mail. If your trash, recycling or Kraft bags are missed, call the Township office as soon as you know you have been missed, at the latest before 10 a.m. the next business day or leave a message on Wendy's voice mail after 4 p.m. the day of trash pick-up. When you leave a message, be sure to include your name, address and phone number where we can reach you and what was missed.

So for those of you who have not attended in the past, we hope you'll join us this year. And bring your family, friends, and neighbors with you!! What Can I Do With My Unused Prescription Drugs? Still have those painkillers in your medicine cabinet from last year's knee surgery?

Did you find a stash of outdated medicines in your grandma's bathroom after she died?

Do you want to get rid of your kid's cough syrup from 1993?

The new drop-off box program provides a secure place for you to dispose of those drugs, keeping them out of the hands of kids, and out of our streams and rivers. The turquoise and

bright-blue boxes here are among 250 MedReturn boxes that have been installed across the state, as part of Gov. Tom Corbett's Healthy Pennsylvania plan.

Residents can drop off prescriptions and over-the-counter pills, liquid medications, inhalers, creams, ointments, nasal sprays, and even pet medications. The boxes are <u>not</u> designed for intravenous solutions, injectables and needles

In Lancaster County, the boxes have been set up from Lititz to Strasburg, mostly at local police departments as well as the county courthouse, where it is overseen by the sheriff's department.

Northwest Regional Police located at 155 Merts Drive, Elizabethtown serves as a drop box location for the Township. The box is located in the lobby of their building and is available 24/7. If the office is closed, ring the doorbell and someone will come to the door to assist you.

Please share this information with family and friends throughout Lancaster County as we all work to support this drug disposal program.

Why Do I Need to Recycle?

Recycling plays an important role in reducing the amount of waste generated by Lancaster County residents and businesses. Every year, LCSWMA manages 297,870.65 tons of waste. County-wide recycling efforts including those within West Donegal Township, administered by LCSWMA, allow for the substantial reduction of waste that would otherwise be put in the landfill.

We recently added all types of paper products to our list of what should be recycled. Recycling bins are available at the Township office. As you may or may not know, how much the Township recycles, residential and non-residential (commercial and industrial) customers has a huge impact on grant opportunities from PA DEP to the Township. Grants are one way that we help offset costs associated with our trash and recycling program. Grant monies help us purchase the recycling containers and brown Kraft bags

and we pass those benefits onto our customers by offering these items at no cost to you. We recently received notification from PA DEP that our Act 101 Recycling Performance Grant was approved for \$11,216.00. This total reflects 1,455.20 tons of residential and commercial materials recycled by the residents and businesses in 2012.

Despite the dangers William started attending Quaker meetings. He was arrested. In court he argued that Quakers had no political agenda and therefore should not be subject to laws that restrict political action. Humiliated, his father kicked him out of the house. William Penn was homeless until he began living with Quaker families. He became a legal defender of Quakerism and wrote pamphlets on their behalf.

Again and again he was thrown in prison because of his religious beliefs, but he continued to write tracts espousing religious tolerance and against discriminatory laws.

When Admiral Penn died, the king found it advantageous to get rid of William Penn by giving him a large tract of land in the New World. William called it Sylvania (meaning "forest" in Latin). King Charles II renamed it Pennsylvania. In 1682, William drew up a frame of government for Pennsylvania. The charter of liberties included free and fair trial by jury, freedom of religion, freedom from unjust imprisonment, and free elections.

He drew up the framework for an ethical society where the power was derived from the people. The new government would safeguard the rights of private property and free enterprise and impose taxes fairly. Prisons would be progressive and swearing, lying and drunkenness were forbidden. William added a revolutionary idea – the use of amendments – to enable change with evolving times. Now William Penn was ready to begin the Holy Experiment – This was our beginning.

Newville Road Bridge Replacement

The Township has notified Kinsley Construction to proceed with the project! The first construction items will be the placement of a foundation and catenary pole in cooperation with Amtrak and the construction of the temporary shield to protect the tracks during construction. This is the best news on the project that the Township has had since the project bid date in September 2012 and we look forward to the completion of the project.





Stormwater Management – New Rules & Regulations

West Donegal Township is completing an amendment to the Code of Ordinances regarding Stormwater Management relating to all construction proposed in the Township. It is anticipated that the new rules and regulations will go into effect in late April.

The Ordinance provides for different levels of Stormwater Management permitting based on the total new impervious area as follows:

0 – 1,000 SF –

Exemption Application required with simple plan and staff approval.

1,001 - 2,500 SF -

Small Project Application with sketch plan. One inch of rainfall from the new impervious area must be addressed. Stormwater management agreement required with staff approval.

2,501 - 5,000 SF -

Minor Land Disturbance Activity requiring plan, stormwater calculations, no increase in runoff rate, volume controls required, and stormwater management agreement with staff approval.

5,000 SF or Greater -

Major Land Disturbance Activity requiring plan, stormwater calculations, no increase in runoff rate, volume controls required, and stormwater management agreement. Approval required of Planning Commission and Board of Supervisors.

There is an Alternate Processing Standard for properties in the Agricultural Zone (A) and Conservation Zone (*C*) with new impervious areas exempt based on the area of the property, location of the property line, and type of conservation plan in place.

All new impervious areas to be constructed in the Township will require contact with the Township and documentation and implementation of the processing requirements. If there are specific questions relating to your proposed project, contact the Township.

From the Code Enforcement Officer

Driveway Permits

Summer will be here soon and you may have considered reconstructing or overlaying your driveway. If driveway work is in your plans be advised that a permit is required prior to the start of work. The permit and inspection allows the Township to review the connection at the road, the review of any swale areas, and sealing along edges. Any increase in driveway area on any lot will require approval under the Stormwater Management Ordinance.

Uniform Construction Codes (UCC) – Residential Construction

UCC permits are required for sheds over 1,000 square feet, fences over 6 feet high, exterior retaining walls over 4 feet high, changes to egresses, in-ground or aboveground swimming pools 2 feet or deeper in depth, uncovered decks more than 30 inches above grade, hardscaping or patios, and utility piping or electric replacement. A UCC permit is also required for repairs that involve cutting away a load-bearing wall, partition or portion of a wall, or removal or cutting of any structural beam or load bearing support.

UCC permits are not required for roof replacements, installation of swing sets, replacement of windows or doors, installation of an uncovered deck less than 30 inches above grade, and interior or exterior painting.

Zoning Permits

A Zoning Permit is required for the following:



- 1. Erection, construction, alteration, extension, replacement, relocation, or conversion of any building or structure or the commencement of excavation or grading for construction of any building or structure; and
- 2. Change in use of any building, structure and/or land other than a change in accessory use.

No Zoning Permit is required for repairs to or maintenance of any building, structure or land provided such repairs do not change the use, alter the exterior dimensions of the building or structure, or otherwise violate the provisions of the Zoning Ordinance. Mandatory On-Lot Septic Pumping

West Donegal Township has completed the update of their Act 537 Plan as required by the PA Department of Environmental Protection. The approved plan by law requires mandatory inspection and pump out of on-lot disposal systems (OLDS) every three years. The Township has begun the planning for the pump out of the on-lot disposal systems which will begin in 2014. The total number of on-lot disposal systems in the Township is 477.

The Township will create three separate areas of the Township which will require pump out in 2014, 2015, and 2016 and then continuing the 3-year schedule. You are required to have your septic tank pumped, an inspection performed, and the applicable forms completed every three years. As proposed, the initial area of on-lot pumping includes the 217 properties on the north side of Turnpike Road and continuing north to the Township line.

Additional details will be conveyed to all property owners in letter form at the start of the year periods. With the receipt of the letter, your property will have the oneyear period to have the inspection and pumping completed. If you have questions on Mandatory On-Lot Septic Pumping, contact the Township office.

Septage haulers who desire to perform pumping and inspection services will be required to complete a Business Registration Application that the Township will provide. This will give information for the residents to review regarding the septage haulers. Those forms will be available at a later date.

Pumping of tanks on a regular basis will extend the life of the OLDS. The inspections will uncover maintenance issues that might not be found until a major problem occurred. Regular pumping is a less expensive solution to replacing a septic system, utilizing a holding tank, or connection to public sewer.



OPEN BURNING IN TOWNSHIP

Do you have concerns about household open burning?

Some may think that burning household trash in a burn barrel does not contribute to air pollution, but think again.

A study conducted by the U.S. Environmental Protection Agency and the New York State Department of Health shows that burn barrel emissions from 2 – 40 households burning their trash daily in barrels can produce levels of toxic emissions comparable to a well-controlled 200 tons/day municipal incinerator. These chemicals can include acid vapors and dioxins.

Burn barrels also emit heavy metals, such as lead, cadmium and chromium, as well as unhealthy levels of carbon monoxide. The closer a person is to waste that is burning, the higher the risk of inhaling dangerous pollutants.

This may not have been the case 50 or even 25 years ago when your parents or grandparents burned trash in a burn barrel. In the past, household waste consisted mostly of paper and glass. Today, metal cans, plastic packaging, plastic products, and other synthetic materials make up a large portion of society's waste. When burned, these items can emit toxic pollutants and contaminated soot particles into the air, which not only affects you but also your neighbors, even more so if they are elderly or experience additional health issues such as asthma or allergies.

In addition to the health effects of breathing the pollutants, flying sparks and embers can easily lead to uncontrolled fires, posing a substantial threat to life and property.

What are the potential health effects of breathing the pollutants from burning trash?

The short-term effects are usually coughing or irritation of the respiratory tract and eyes. Smoke can be a vehicle for deep penetration of pollutants into the lungs.

Long-term exposure to these pollutants may lead to cancer and emphysema. Acid vapors can irritate the lungs and cause problems for people suffering from asthma and emphysema. Dioxins are linked to increased risks of cancer, delays in child development, and damage to the immune system.

Recycling & open burning within the Township.

Does West Donegal Township recycle? Absolutely! West Donegal Township has enacted a residential waste recycling program under the Municipal Waste Planning, Recycling and Waste Reduction Act of 1988 (Act 101). Therefore, it **IS** illegal under Act 101 to burn the kinds of waste and materials that the municipality requires residents to recycle. Under Act 101, leaf waste must also be separated from other municipal waste. Leaf waste is composted by either the resident or the municipality which means that leaves should **NOT** be burned.

West Donegal Township regulations and its accompanying ordinance are efforts to work with the local elected officials to enact an open-burning ordinance that is as fair as possible to everyone. Since the Township operates under Act 101, to receive state recycling grants, we must have an open-burning ordinance that prohibits the burning of the materials that the municipality recycles. Even though we collect leaves, yard waste and woody waste as part of our recycling efforts, composting and grasscycling are also strongly encouraged. Nordstrom To Open Fulfillment Center In West Donegal Township

Nordstrom recently announced plans to open its third fulfillment center at Conewago Industrial Park in West Donegal Township. The approximately 672,000-squarefoot building, with an additional 470,000-square foot mezzanine, is scheduled to open in summer 2015. In its first three years, the new fulfillment center will offer nearly 400 full-time positions and additional opportunities for part-time and seasonal roles. In the future, Nordstrom expects to increase hiring - up to 700 full-time roles or more as the business continues to grow.

The fulfillment center will enable faster delivery for Nordstrom. com, Nordstrom mobile app and Nordstrom catalog orders, particularly for those from customers on the East Coast.

The fulfillment center is located along Zeager Road at the Conewago Industrial Park, which is owned by Martin and William Murray, and will be built by H&M Company, Inc. of Jackson, TN.

Site work, east of Zeager Road, has begun and roadway widening of Zeager Road, turn lanes on North Market Street at Zeager Road, and construction of a traffic signal will commence in April and continue until completion.

2014 Road Work While the list of road work for 2014 has not been finalized

and will be subject to bidding results, the following streets/roads are under consideration. Micro-surfacing of Farmcrest Lane, Shamrock Drive, Aspen Drive, Silverleaf Drive, Meadow Road, Verna Court, and the remainder of Rhoda Avenue and overlay of Crestview Drive. When the bids are received and selection complete all residents in the areas of construction will be notified of the pending work.
