## **Meeting of may 9, 2018**

The resular meetins of the west conesal township planning commission was called to order at 7:00 p.m. by chairman wayne miller with the pledse of allegiance, a moment of silent prayer and the announcement that the meetins is being taped for minute taking purposes. Commission members present were wayne miller, don kreider, John martin, John Brandt, and Eric Kreider. Also in attendance were gene oldham, Township manaser, Jennifer prunoske. Hanover Ensineering. And Pat Kadel. Lancaster county planning commission.

**MINUTES:** The Minutes of the March 14 meeting were approved on a **pranct/martin** motion. Motion carried. The Minutes of the april 11. 2013 meeting were approved on a **pranct/n. kreider** motion. Motion carried.

### **AGENDA ITEMS:**

1. Final subdivision plan, donesal woods phase 1B, James Boyer, PE, David Miller/Associates, Inc. (1sh Review) James Boyer of David Miller/Associates, Inc. and Gres Kile, owner were present to represent the plan. And Ensineer's review was provided by Eusene Oldham, PE, PLS, in his Letter, dated may 2, 2013. The Township solicitor provided review comments via a Letter dated April 16, 2013. Mr. Boyer explained that there were two chanses since the phase 1B plans were submitted. The two stub streets — Amber wood lane and acorn lane — will not be completed during this phase. Instead, the homes originally slotted to pront on those streets, will be revised to pront on Freys Road and those two streets will be deperred to be developed until the next phase.

MP. OLDNAM recommended that easements should be marked prior to development. Mr. Boyer and Mr. Kile concurred that this recommendation could be done.

- A **D. Kreider/Orandi** molion was made to table the Plan. molion carried.
- 2. Final subdivision plan for stoneybrook phase IB and Lot Add on plan, Todd smeigh, D.C. Gohn Associates, Inc. (1% Review).

DUE to a conflict of interest, Mr. Miller dismissed himself and deferred chairmanship to Don Kreider For this Plan. Mr. Oldham also excused himself from the table. The meeting continued with Mr. D. Kreider as acting chairman

TODO SMEISH WAS ON hAND TO PRESENT THE PLAN. HE EXPLAINED THE ORIGINAL PLAN WAS AN OPEN SPACE development. He then continued by explaining that the new concept will include phase 18 with 52 lots and all associated improvements and the addition of the lot add on was required by the Lender. Review comments were provided by the Township Engineer in their Letter, dated may 2, 2013, and the Township solicitor, dated april 23, 2013. Per the Township solicitor review, a zoning Hearing will be required as it is a non conforming lot. mr. smeigh stated that there are numerous joint permits, along with a required zoning Hearing, and lots of work to be completed prior to any plans being submitted for Township review. The plans were tabled on a **martin/prands** motion. Motion carried with mayne miller deferring from the vote.

- N Kreider passed chairmanship hack to mr miller
- associates, inc. was present to plan review, deper to mount joy township todd smeigh of d.c. Gohn associates, inc. was present to plan. mr. smeigh explained that the church's property is located in mount joy; however, the adjoining property line extends into west donegal township. Therefore, they are asking for the plan review to be deferred to mount joy township. It was agreed on a **martin/b**.

  \*\*Reider\*\* motion to this verbal waiver request contingent upon the completion of the required appendix 17 with all applicable fees being paid to west donegal township. motion carried.
- 4. SALDO (8<sup>rd</sup> Review) Ms. Prunoske stated that LCPC Provided an informal review and Gene, wayne and she reviewed their comments and added a few revisions/additions. She provided a brief synopsis of those revisions/additions. On a **D. Kreider/Brandt** motion the draft saldo will be shared with the Board of supervisors with the additional comments of the addition of the walking trail topping as agreed upon at tonight's meeting. Motion carried.

- 1. ACT 167 The COUNTY has reviewed and approved the Plan. It has been sent to DEP for their final approval. Municipalities will receive a letter from DEP indicating six months to implement a new stormwater management ordinance.
