# **Shredding Event**

West Donegal Township is partnering with East Donegal Township and Mount Joy Township to host a shredding event on Saturday, September 18th from 8 am to 12:00 noon at the West Donegal Township municipal building located at 1 Municipal Drive, Elizabethtown, PA.

This event will be free of charge to all residents living in West Donegal Township, Mount Joy Township, and East Donegal Township. We will be limiting the amount of shredding to four boxes or bags of paper per property to be shredded.

As it our wish to help others within our community, again this year we are asking those participating in this event for donations of canned goods and boxed items (monetary donations also accepted). Please be generous as these donations will be given to the local food banks. Their greatest needs include canned meats, juice, canned/boxed pasta, jams/jellies, cereals, pancake mixes and syrup, and paper products. Baby food and formula will also be accepted. Please no perishable items. Donations should be non-expired, non-breakable, and all items should be in unopened containers. Glass, frozen food, fresh produce/meats or home-made food will not be accepted. Your help is truly appreciated by those in need in our community!



# **Medication Disposal Box**

West Donegal Township now has a Safe Medication Disposal box in the lobby where residents may dispose of expired and unused prescription drugs and over the counter medications. This box is secure and will be emptied as needed by the police department who will make sure the drugs are disposed of in the proper way.

Any prescription medications and over the counter medications will be accepted. Illegal drugs, needles, lotions or liquids, inhalers, aerosol cans, thermometers and hydrogen peroxide will not be accepted. Labels should be removed from all prescription bottles before bringing them in.



# Credit Card & E-Check Payments Accepted Online

Residents have the option of paying their Trash Bill or permit payment from the comfort of your home using our online payment service. Credit cards accepted: MasterCard, Discover, American Express or Visa. A per transaction service fee of 2.65% or \$3.00 minimum will be charged by the payment processing company for this service. E-checks are also accepted online with a flat per transaction fee of \$1.50 - just click the option on the payment page to change your payment method.

# Clip & Save

## White Goods & Tire Curbside Pick Up

#### Saturday, April 24

All white goods and tires must be tagged and placed curbside the night before collection. Tags cost \$12.00 per white good

and \$3.00 per passenger car or motorcycle tire and must be purchased at the Township office. If you have tires larger than a passenger car or motorcycle tire, contact the Lancaster County Solid Waste Management Authority (LCSWMA) at (717) 397-9968 for disposal of these items. There will also be a White Goods and Tire pick up on Saturday, October 16.

#### Woody Waste and Yard Waste Collection

Woody Waste and Yard Waste will be collected every other Tuesday beginning April 6 through October 6. Yard Waste must be placed in brown biodegradable Kraft bags which are available at the Township office. There will be a charge of 5 bags for \$1.00 and 10 bags for \$2.00. We ask that you keep the Kraft bags protected from the weather elements until the day they are placed curbside. The Kraft bags should be placed curbside the night before collection with your regular trash but will be collected by a separate recycling truck. Any yard waste placed in plastic bags during this time will not be collected. Woody Waste should be bundled with biodegradable twine. Branches should be no longer than 4' in length and not more than 6" in diameter.

Reminder: DO NOT recycle Grass clippings! Play it green by mulching them or they can be placed in trash bags for disposal (3 trash-bag limit still applies. Extra bags of trash will need a neon yellow tag). Disposing of fruit or vegetables from a garden is NOT considered yard waste (it is food). However, fruit from trees may be included in the Kraft bags.

### **Holiday Trash Schedule**

Memorial Day – Trash and recycling collection will be delayed by one day and collection will occur on Wednesday, June 2 & Thursday, June 3.

**4th of July** – Trash and recycling collection will be delayed by one day and collection will occur on Wednesday, July 7 & Thursday, July 8.

**Labor Day** – Trash and recycling collection will be delayed by one day and collection will occur on Wednesday, September 8 & Thursday, September 9.

**Reminder:** All trash/recycling must be curbside no later than 5 am the day of pick up. Trash must be in 32-gallon trash bags or cans that weigh less than 30 lbs. Please be sure all trash is bagged even if the bags are in trash cans and actual trash cans are used (no barrels or other containers). All ashes, i.e. coal and wood, must also be bagged.

For oversized items (any item that can be disposed of curbside but doesn't fit into a trash bag), contact the Township office. Many of these items can be disposed of curbside with a \$4.00 red tag. There are also strips of four neon yellow tags that can be purchased for

bags are missed, call the Township office as soon as you know you have been missed, at the latest before 10 a.m. the next business day or preferably leave a message on Wendy's voice mail after 4 p.m. the day of trash pick-up. When you leave a message regarding a missed stop, be sure to include your name, address, and phone number where we can reach you and what was missed.

# From the Zoning Office

## **Property Maintenance**

The Township will continue conducting surveys of properties to determine compliance with the IPMC (International Property Maintenance Code) which regulates things such as yard and grounds maintenance, inoperable or unlicensed vehicles, building (structural) maintenance and general building repair, trash, refuse or discarded building material accumulation, swimming pools and spas, etc. Failure to acquire required permits or properly maintain your property in accordance with the minimum requirements will lead to notice of violations, fines and/ or condemnation proceedings. The Township expects voluntary cooperation from the residents for these basic maintenance issues and welcomes the chance to talk with the residents about ways to enhance the overall appearance, function and safety of the properties within the Township.

## **Building Permits**

n 2004, West Donegal Township adopted the Uniform Construction Code (UCC) established under Act 45 of 1999. The purpose of the UCC is to protect the public health, ensure safety of building occupants and protect property from failure and destruction. Plans/drawings along with a Construction Code Permit Application is required to be submitted under the UCC. Projects include but not limited to: Buildings over 1,000 sq ft, new construction, sprinkler systems, attached carports, attached garage, decks over 30", any pool 24" and over, hot tubs/spas, enclosed patios, solar panels and geothermal systems.

## **Zoning Permits**

A Zoning Permit is issued for compliance with the West Donegal Township Zoning Ordinance. Projects include but not limited to sheds, fences, decks below 30", patios/pavers, walkways, gazebos, retaining wall less than 4' and unattached carports.

## **Stormwater Permits**

In 2014, West Donegal Township adopted the Stormwater Management (SWM) Ordinance designed to manage stormwater from the construction of new or additional impervious surfaces. The SWM Ordinance requires that an owner or authorized agent who intends to add impervious coverage must submit a Stormwater Management Plan, unless exempt within the guidelines of the ordinance.

# FAQ's:

## Am I allowed to have chickens?

Yes. Maintaining small domestic animals shall be within the rear yard area, must be kept in a fence, fence must be at least 50' away from any lot line and not closer than 100" to the nearest dwelling unit other than that of the owner, area must be kept maintained and animals shall not be a nuisance in terms of excessive noise, dirt, or odor. Ordinance 240-98 B.

# Do I need a permit to replace my driveway?

Yes. The Driveway Maintenance Permit can be found on our website or obtained at the Township.

What is the setback for a fence? Fences may be placed on property lines if you know where the property pins are located. Fences in the front yard are limited to 4' and must be out of the Township right-of-way. If you are uncertain it is recommended you hire a surveyor. Fences may not interfere with the flow of stormwater.

#### When are Zoning Hearing Board Meetings and when are the deadlines to submit application?

Zoning Hearing Board Meetings are held the first Wednesday of every month. The deadline to submit is 3 weeks before the scheduled hearing. The application fee is \$650 for residential and \$750 for business.

### My project has been completed but I didn't receive a Certificate of Occupancy. Where do I get a copy for my records?

After your project has received the final inspection from Commonwealth Code Inspection Services, the Township will issue you a Certificate of Occupancy.

# Do I need a permit for a swimming pool?

Yes. Any body of water more than 24" deep is considered a pool and must meet safety standards.

*How long is a permit good for?* One year.

# Mandatory On-Lot Septic Pumping

While part of the Act 537 Plan approval by DEP, the pumping and inspection of an on-lot disposal system on a regular basis helps extend the life of the system. Property owners in Pumping District No. 1, the area north of Turnpike Road, must comply with the regulations regarding on-lot pumping and inspection by June 30, 2021. A letter and the required form were mailed to each property owner last year. If you did not receive the information, please contact the office. On July 1, 2021, Pumping District No. 2 will have one year to comply with the requirements. Property owners in district 2 will be notified via a letter and required form in June of 2021.

There are many signs of a failing septic system; backup of sewage in your drains or toilets, decreased flushing of your toilets, decreased drain flow from showers and sinks and unpleasant odors in your home. Issues with your tank could present as an over-flowing or near overflowing of your septic tank and high solids accumulation in your septic tank. Water accumulation and wet patches in your drain field can also be a sign of a failing septic system. Be careful of what you dispose of in your toilet or down your drains. Never put plastics or any other nondegradable items into your septic tank. It is also imperative that the toilet paper you use be septic friendly; many brands will state septic safe on their packaging. By properly managing your on-lot septic system you are helping to extend the life of your system by alerting you of potential failures. It's important to take the time to educate everyone in your household about the importance of practicing good on-lot septic system management habits.

Every day (on average across the nation) 3 responders are struck and injured at the scene of a roadside emergency that they have been dispatched to, some suffering life-long, career-ending injuries. As if those injuries are not sobering enough, as of February 17, six responders have been **struck and killed** by a passing motorist in 2021. (In 2019, 44 emergency responders were stuck and killed, and in 2020, 46 were stuck & killed - including two Pennsylvania responders; Paramedic Matthew Smelser (43) and firefighter/tow operator Tyler Laudenslager (29).

As an agency that responds to hundreds of incidents that occur on roadways (traffic accidents and medical emergencies), these struck by incidents concern us. We, like all responders, just want to go home at the end of our shift And we believe they key to reducing these tragedies is educating the motoring public.

On April 27, 2021, Pennsylvania's Move Over law is fully in effect. This law, an updated, enhanced version of an existing Steer Clear law, provides for a number of deterrent consequences that the previous law did not address, such as a directive to move over at least one full lane of travel when passing an accident or work scene, and to slow down at least 20 mph below the posted speed limit. But a law cannot truly prevent these tragedies. It is an action by the motorist that is required.

Northwest EMS Community Outreach Manager, Lori Shenk, who also serves as co-chair of the Public Education and Outreach Committee for PennTIME (Pennsylvania's Traffic Incident Management Enhancement team), has been working with responders and state and local officials across the Commonwealth on awareness and education initiatives. One of those initiatives is the production of a state-wide Public Service Announcement (PSA) to be released in advance of the law's implementation. The hope is that the PSA will promote awareness of these tragedies and encourage practical application by motorists to SLOW DOWN and MOVE OVER as they pass these working scenes.

On Saturday, March 27, the Manheim Auto Auction (Penn Township) was the sight of filming for the PSA which included dozens of responders from all disciplines, with more than 100 pieces of apparatus. This production event was not open to the public, but it was an opportunity to pay tribute to responders who tragically lost their lives in a struck/killed incident and to honor those responders who have been struck and injured. Most importantly, it was an opportunity to create an impactful message that we hope will save lives. We hope, through release of the PSA, to reach every citizen of the Commonwealth with our message to SLOW DOWN and MOVE OVER when passing a scene where responders are working. The PSA will can be used on a variety of media platforms, including social media and websites, as can the graphics and messaging be displayed on billboards and electronic sign boards across the state.

*Slow Down* and *Move Over* is more than a slogan. It's a cry for response and a call to action. *WE ALL JUST WANT TO GO HOME AT THE END OF OUR SHIFT!*

# **Northwest EMS**

Northwest EMS recently began offering an Emergency Medical Technician course in conjunction with the Elizabethtown Area School District. This is the only EMT program in Lancaster County offered by a combination of an EMS service and a school district. The class lectures and clinical time prepare students ages 16 to 18 to take the Pennsylvania EMT examination, which tests them in practical skills as well as medical knowledge. Students who will be 16 years old in the fall can talk to their guidance counselor about enrolling in the next class.

Thanks to all who have responded to the annual subscription drive with fees and extra donations. Those who subscribe receive the benefit not having to pay the portion of their ambulance bill that is not paid by insurance, plus they help support the equipment and training needs of this community-based, non-profit service. # From the Manager's Desk – 2021

#### MS4 Update

Last year at this time I introduce you to the MS4 permit in West Donegal Township. MS4 stands for "Municipal Separate Storm Sewer System". We were required to apply for this permit by the PA DEP because of the population density within our urbanized area (Rheems, other housing developments and the Conewago Industrial Park). This permit allows the Township to discharge stormwater from our urbanized area (UA) into local streams and water courses (a.k.a. "Waters of the Commonwealth") which ultimately empty into the Chesapeake Bay. Part of our responsibility under this permit is to inspect all the stormwater management basins and other structures and facilities both public and private throughout the township to ensure they are well maintained and in good working order. We refer to these items as BMP's or "Best Management Practices". The responsibility for the proper care and maintenance of these facilities falls to the property owner where these facilities are located. In the case of some housing developments, the responsible party might be the Homeowner's Association if one exists. #### West Ridge Road - Maytown Road Intersection.

Early in December of 2020, we closed the one-way exit spur from Maytown Road to West Ridge Road which passes in front of the old schoolhouse (the centerpiece of our logo) next to our public works buildings. We took this action after observing several motorists on the same morning ignoring the "DO NOT ENTER" signs and then traveling the wrong way down the spur to enter Maytown Road against the established flow and in both instances nearly causing accidents on Maytown Road. Sadly, this was just the latest instance in what over the last 18-24 months has become an occurrence whose frequency we could no longer ignore.

Since the closure in December we have reviewed the situation with our township engineer and the traffic safety engineer for PennDOT District No. 8 who covers our area. The consensus opinion is that this one-way, single lane section of West Ridge Road should be removed as there is no good mechanism available to leave it in place and prevent the continued violations from occurring. The township has decided to move forward with this removal sometime during the 2nd or 3rd quarter of this year. We are currently waiting for our permit from PennDOT to allow us to work in their right-of-way for the removal of that portion of the spur that exists there. We understand that changes in pattern can be frustrating and inconvenient however, we could no longer stand by and wait for a potentially serious or fatal accident to occur before acting.

Some residents have expressed concern about traffic flow exiting Maytown Road on to West Ridge Road as a result of this change. We plan several revisions in conjunction with the spur removal to improve this flow. The first item is the immediate removal of the stop sign that existed just off Maytown Road. When you exit from Maytown on to West Ridge, you no longer need to stop but should continue to move by either making a left turn to continue west on West Ridge Road or making a right turn and proceeding toward Municipal Drive and the Township Building campus. The stop sign where Municipal Drive once met West Ridge Road has been relocated so that Municipal Drive traffic must stop, giving the right-of-way to vehicles exiting from Maytown Road to West Ridge Road. The existing "STOP except right turn" sign on West Ridge Road as you approach the turn to the Maytown intersection will remain. We also plan to increase the radius of the curve leading from West Ridge Road to the 90-degree intersection with Maytown Road. This should also make traffic movement easier for vehicles exiting from Maytown Road. Finally, we have placed a workorder with PPL to add a streetlight to the utility pole adjacent to this intersection to improve the night-time visibility of this



intersection. All the above proposed revisions have been reviewed and approved by our township engineer and PennDOT. Timing of this project will depend on receiving our permit from PennDOT, the status of other projects in our pipeline and of course the weather. Please refer to the illustration with this article to get a better understanding of the proposed revisions.

# Stormwater, Bridge and Roadway Projects for 2021

Spring is upon us and summer is just around the corner. Our road department has shifted their focus from snow removal to our roadway and stormwater maintenance projects for the 2021 season. The COVID-19 pandemic wreaked havoc with our 2020 stormwater project plans so we will revisit them in 2021. We are planning a major storm sewer pipe replacement project on Stonemill Drive between Rutts Road and Garber Road. This work will require closure of the roadway during business hours only over the course of the project. Motorists should expect rough roadway where pipe trenches cross the road until the project is complete and all trenches have been final paved.

The stormwater project is our first priority and if time permits, we may elect to do some maintenance work on the timber bridge over the Conoy Creek on West Ridge Road, just west of the intersection of West Ridge and Miller Roads. The exact timing of both projects has not yet been determined. These projects will not occur at the same time. Please watch the Township's website and Facebook page for closure and detour information as it becomes available. As with all our roadway projects, dates and times are weather dependent and subject to change.

The Township is planning maintenance work on the following roadways:

- Blue Jay Circle in its entirety, oil and chip.
- Dogwood Circle, Dogwood Drive, Poplar Lane and Magnolia Drive in their entirety, oil and chip.

Every year, we get some form of the following question: "Why does the township keep messing up our roads with that oil and chip stuff, why don't they just pave it?" Oil and chip is a very cost effective way for the township to keep the roads in good shape. Paving is very expensive, up to 10 times costlier per square yard. With just over 50 miles of township road to maintain, we need to make every dollar we receive in roadway maintenance funds from the state stretch as far as possible.

Oil and chip seals the road surface and keeps it from breaking apart, prolonging its life. We use this application if the road still has profile (a crown in the center with good drainage both left and right and no ruts) to refresh the oils in the road, seal it, lengthen its life and improve traction. It typically takes 3-7 days for the oil to fully cure, depending on weather conditions following application. Once the oil has cured, our contractor comes back to sweep up any loose stone chips that remain.

Here are some tips for driving on roads that have been freshly oiled and chipped:

1) Drive SLOWLY - if you can hear the chips hitting your car, you're going too fast. You can avoid getting stone chips and tar on your car by driving SLOWLY.

2) Never drive between the oil truck and the stone truck.

3) Follow all directions given by the road crew and flaggers if you need to travel on a road that has an oil and chip operation in progress.

The oil and chip work is currently in the bidding phase. Please watch the Township's website and Facebook page for updates as dates for this work and the resulting travel restrictions become available. # West Donegal Township Past to Present Part 16 – Union School

(An ongoing saga of West Donegal Township by Mary Conrad)



Just fourteen years after the signing of the Declaration of Independence, the Pennsylvania state constitution was approved. Those in leadership positions wanted a free public education so all residents could learn English. Every voice was needed to establish our new nation. According to the 1790 census, Pennsylvania was the "most foreign" of all thirteen colonies.

The "Free School Act of 1834" was passed by the Pennsylvania Assembly to assist in the vision of a free nation. The earliest schools were supported by churches. Later, locally elected school board directors had the power to levy taxes to build and supply schools.

On September 2, 1879, West Donegal Township school officials purchased an ½-acre tract of land for the sum of \$93.43. The Union School building was constructed during the early months of 1880. It was a frame building painted white. A report of the Union School stated that 46 pupils were enrolled as of December 1880. John G. Goss was their leader.

The West Donegal School Board built Union School between the Rheems and Rutt one-room schools (Rutt schoolhouse once stood at the corner of Rutt and Bainbridge Roads). The school board felt that children should not have to walk more than 2 or 3 miles to school. Union School had grades 1 through 8. At the end of 8th grade most children stopped attending school to become an apprentice and begin full-time employment.

Years later during schoolhouse reunions, former students would reminisce. Harvey Reem, Sr. remembered this was a period where girls wore high-buckle shoes ad older boys were "shod" with leather boots. Harvey remembered the day he received his first pair of boots. One day on the way home from school, Harvey decided to find the depth of every mud puddle. The leather became saturated to such as extent that by morning the leather was as hard as a board. When his mother discovered the condition of his boots, she awoke him early to "dress up" the boots with an application of skunk grease to soften the leather.

More Union School memories and later use of the one-room school building will continue in the next Township newsletter.
